### Handicapping

Handicap will be based on 90% of the difference between the Bowlers Previous Year's Highest USBC Average and 230. If entrant does not have a Previous Year's USBC Book Average, the next previous year's Book Average will be used or a Current League Average of 21 or more games. League Sheet must be presented for verification. Bowlers with no average verification will bowl with (0) Zero Handicap. Averages will be verified using the USBC Web Site and adjusted accordingly. Director will not be responsible for errors posted on the USBC Web Site. 10 Pin Rule will be in affect. \* Maximum Handicap \* 229

This is an Amateur Bowlers Tournament and Professional Bowlers are not permitted to participate in this competition.

If an entrant appears to possess skills well above his/her Entering Average, the Director will have the Authority to re-rate his/her Entering Average in establishing his/her Handicap. The Director will have the Final Decision. No Entry Fees will be returned.

### Format

The Format includes the total of the scores of the (3) Three Qualifying Games (Series) added to the Handicap. Bowlers will be bowling (3) Three Games across (6) Six Lanes. Field will be Cut in Half with Top Higher Scoring Qualifiers bowling in a (1) One Game Beat the Board Finals using (1/3) One Third of your Total Handicap to determine your Final Score. (1) One of (5) Five of the Total Entrants with the Highest Scores in the Finals will Cash.

In the event of a Tie for the Championship or Runner Up Position, there will be a (2) Two Frame Roll Off using (1/5) One Fifth of your (1) One Game Handicap to determine your Final Score. All other positions will split the designated Prize Money.

In the event of a machine failure, Director has the authority to move entrants to another pair of available lanes transferring what frames were completed.

Participants unable to continue the Competition will not have their Entry Fees returned.

All Prize Money will be paid at the Completion of the Tournament. In the event there is a Discrepancy, the Director will have the Authority to hold payment until the problem is resolved.
