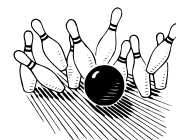

Skilz Athletics 3-N-1 Shootout Rules

3-n-1 Shootout starts on Saturday March 13, 2010 at 12pm and ending on Sunday March 14, 2010 at the completion of the 5pm squad. Open to all Men and Women USBC sanctioned bowlers.

1. Doubles can consist of any combination, 2 men, 2 women and /or mixed team.
2. Current *PBA/PWBA* members are welcome, but only one per team.
3. Scores bowled in Doubles will used for all optional events entered for the same squad.
*****You must be entered in Doubles in order to alibi*****
4. Bowlers will bowl three games across six lanes.
5. Bowlers may re- entered as often as they wish, but can cash only once with the same partner in Doubles.
6. Handicap shall be based on 90% of 210, 40 max- Men & 50 max – Woman.
7. Entrants will use their league book average of 2008/2009. If their current league average is 10 pins or higher, then their current league average will be used. (Whichever is highest). If you don't have any of the previous mentioned criteria you will bowl scratch (210).
8. All averages must be verified prior to entering the tournament. Corrections in average are permitted up to the completion of the first game. Bowlers must verify their own average and initial by their name on the recap sheet.

Failure to report correct or re-rated average; bowler(s) will be disqualified!

9. Payoff ratio is 1: 8. Prize fund is 100% returned.
10. **Skilz Athletics Inc.** reserves the right to rule on all questions or disputes; our decision is final. We also reserve the right to re-rate the average of any bowler before participation in Tournament or re entry.
11. USBC rule 319D and E is effect for all. Bowlers who cashed \$600 or more in any one tournament within the past 12months must report it prior to bowling.
12. Scores lost due to power failure or mechanical failure must be re-bowled. (USBC 327c). No money will be refunded. Any appeal or protest regarding tournament scores shall be made in writing to the *Skilz Athletics Inc.* . Action will be in compliance with USBC rules.

Any rules not covered within shall be governed by USBC rules.
